# Locking - Class B and Class C Security Containers

All our Class B and Class C Secure Wall Mount Cabinets are fitted with the appropriate security level locking solutions.

Class B cabinets are fitted with the very latest KABA X10 digital locks, which are designed to be resistant to all forms of external manipulation and environmental attack. The Kaba X-10 is the trusted choice for securing the Australian Government's most sensitive material. Another SCEC approved lock is the S&G 2740 Class B. Featuring advanced electromechanical design, the 2740B can be used on all SCEC approved cabinetry requiring a spyproof dialing sequence.

Class C cabinets are fitted with the BiLock, the most recognised high security master key system in Australia. BiLock incorporates a new futuristic key head specifically designed to incorporate extensive colour coded master keying capabilities, ensuring optimal security. With over 8,000 colour combinations available, this new key head visibly defines the security levels within a master key system and allows instant identification of keys by system managers.







# Security and Compliance

SRA Solutions comply with strict SCEC door specifications, that the cabinet structure  $\,$ extends a minimum of 20 mm above and below the door opening. The door itself must also be recessed into the cabinet and is further strengthened with a stiffener welded to the internal face. The door is not to be removable from the container body and not to be reliant on the hinges for security.

Wall Mount Cabinets include a CEB (Cable Entry Box) with internal covers and pathways that meet stringent SCEC requirements. Please note that all cable baffles, covers and protected pathways may be temporarily removed for the installation of network cabling. Racks which do not have these battles, covers and protected pathways re-installed, are not SCEC approved for the storage of equipment used for processing security classified information.

#### Unique Serial Number Identification

Each security container is identified with a nine digit serial number, which is permanently marked on an identification label in the uppermost right hand front corner of the security container.

As standard, each Wall Mount Cabinet has a single 4 way CEB fitted in the front top position. SRA Solutions are also able to mount a CEB at the bottom front position, or configure 2 CEB cable entry positions in a single cabinet, front top & bottom.

Maximum cabling volume up to 200-400 CAT6 cables.



All cabinets in the SRA Solutions wall mount range are manufactured from zinc annealed (rust proof coating) steel. These cabinets are fully welded and load rated to 30kg distributed weight. The top and bottom of each cabinet has a low 50mm profile to minimise the overall height.

Please note that cable baffles, covers and protected pathways, may be temporarily removed for the installation of network cabling, however, they must be reinstalled in order to retain the SCEC approval of the rack as a security container.

Racks which do not have these baffles, covers and protected pathways reinstalled, are not SCEC approved for the storage of equipment used for processing security classified information.

# Wall Cabinets - Rear Mounting

The rear wall mounting panel can be bolted to any structural building surface utilising the provided 6 x M10 mounting holes. This allows the panel to be reversible onsite, providing maximum flexibility when installing into tight spaces.

The main body is attached by full length piano hinges. It is swung back against the wall mounting panel and retained with 2 locking plates that slide to secure the cabinet in place.

The mounted swing frame is designed in accordance with SCEC requirements: -

"Wall mounted containers shall be secured to the wall using an intermediate-frame. The frame shall allow the container to be swung away from the wall to allow the inspection of the rear of the container for tampering."
